As per SEBI Circulars dated November 3, 2021 and December 14, 2021, unclaimed dividends will be credited directly to the bank account, if the folio is KYC compliant. Unclaimed dividend can be paid to shareholders holding shares in physical form if the folio is KYC compliant.

In case the dividends are not claimed before the due date, i.e., **September 05, 2026** necessary steps will be initiated by the Company to transfer shares held by you which are due for transfer to IEPF without any further notice, in accordance with the Rules.

In case the shares are held by you:

- In physical form – New share certificate(s) will be issued and transferred in favour of IEPF on completion of necessary formalities. Hence, the original share certificate(s) which stands registered in your name will be deemed cancelled and non-negotiable.
- In demat form – The Company shall inform the depository by way of corporate action for transfer of shares lying in your demat account in favour of IEPF. Please note, that no claim shall lie against the Company in respect of the shares so transferred to IEPF.

Shareholders may note that, both unclaimed dividend amount and the shares transferred to IEPF Demat Account can be claimed from IEPF Authority by making an application to IEPF in web based Form IEPF-5 and sending the copy of the same duly signed (as per the specimen signature recorded with the Company) along with requisite documents enumerated in the Form IEPF-5 to the Company at their Corporate Office i.e., 3rd Floor, Astarc House, 76-79 Makwana Lane, Marol, Takpada, Andheri (East), Mumbai 400059.
